**PROJECT TEAM AND END USER TRAINING**

**HOW IT WORKS**

The development team consists of:

- **Senior Project Manager/Analyst** - focuses on resolving issues and complex testing (may be on-site at client)
- **Development Team** - combination of remote senior and junior developers to be cost effective
- **Testers** - junior tester compliments Senior Business Analyst and does majority of testing (may be on-site at client)

Benefits of the remote model includes:

- Ensures focus on the work and less distractions on client site which means more effective use of developer's time
- Development occurs across many time zones

Development is performed in a copy of client's database. The client runs a script (provided by Kestrel) on the copy database to scramble all client sensitive/confidential data which means at no time is there sensitive/confidential data off-site.

Once development is delivered and being tested by the Tester (and Client) - the developer can, at any stage, access the Client's database via remote access (e.g. Citrix) where available and can also perform live updates on the test database. The on-site developer may also send pop files to the remote developer if required.

Where required the Developer/s may be available on client site for cutover/go-live when suitably planned for.
